Citizens lack knowledge of their rights and how to engage with police processes.

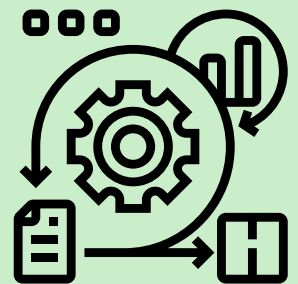


FEAR OF RETALIATION
